Selection Process:

For consideration, eligible candidates will be invited for Personal Interview in the ratio upto 1:10 to the number of vacancies. In case of receipt of more no. of eligible applications beyond the ratio of 1:10, shortlisting for interview will be done in the ratio 1:10 on the basis of qualifying marks in the relevant qualification of Degree/Diploma in Civil, as the case may be.

General Instructions:

1. The **posts are purely temporary in nature and offered on fixed tenure basis for a maximum period of Two Years. This post is not against any permanent vacancy. This placement will not entitle the candidate for any regular / permanent employment in BHEL in future.**
2. Candidates should possess the required Job Specifications as on **06.02.2019**.
3. Candidates not having relevant 2 year post qualification experience in areas mentioned under "Work Experience & Capabilities" need not apply. (**Note:** 2 Year Post Qualification experience should be exclusive of Trainee/Apprenticeship period, if any)
4. Candidates should be able to furnish their relevant Degree / Diploma and Post Qualification Work-Experience certificates at the time of Interview.

6. Category such as OBC, SC, ST & EWSs should be carefully filled-up in the online application format as this will not be allowed to be changed at a later date.
7. OBC candidates who do not belong to Non-Creamy Layer should submit their application under **Unreserved** category only.

12. Candidates are advised to possess a valid e-mail ID which is to be entered in the online application Form.
